Poker Hill School is a qualified prekindergarten program through the State of Vermont and therefore children enrolled in Poker Hill School are encouraged to apply for and receive publicly funded tuition (10 hours a week, for 35 weeks during the school year). Act 166 funds are applied to the child's 10 hours a week and those 10 hours are at no extra charge.
